ELIGIBLE RAFFLE TICKET PURCHASERS:

Tickets can be bought in the name of ONE person with a valid address, phone number and email address. If tickets are purchased, a tax receipt will not be issued for the dollar amount of the tickets purchased. Please note that anyone who is physically in the province of Quebec can buy a raffle ticket, whether they are a tourist, a temporary worker, or a citizen.

Kurling for Kids reserves the right to refund OR refuse the purchase of a ticket if it is found that the contact information is incorrect, unverifiable, or has been used without the owner's consent.

TICKETS AND PRIZES:

There will be a maximum of 20,000 tickets sold; numbered from 00001 to 20,000. Tickets will be sold online at www.kurlingforkids.org and by K4K participants on a first-come, first-served basis until 7:00 pm on Saturday, September 26th, 2026 ("Draw Date") or until 20,000 tickets are sold, whichever comes first.
